// 2.0 INSTALLATION REQUIREMENTS

The appliance is supplied with a pre-wired three pin BS1363 plug (13 Amp fuse rated) and 1.6 metres of electrical flex. It is therefore necessary for a suitable electrical socket to be located within this distance of the appliance and be easily accessible. The stove may be installed on a combustible or non-combustible floor, however the heater outlet is underneath the stove and certain types of floor covering may be affected by the heat produced by the stove. The ability of the floor covering to withstand the heat produced by the stove should be ascertained before proceeding with the installation of the stove. If in doubt then the stove should be mounted on a non-combustible hearth or plinth which extends for at least 150mm in front of the stove. This appliance should be positioned on a firm level surface. If the stove is to be sited in a fire surround then the suitability of the surround for use with electrical heaters should be established with the fire surround manufacturer. If fitted into an open draught fireplace, it is advisable to block off the chimney to reduce the risk of draught through the stove which may cause the safety cut out system in the fan heater to operate.

// 4.0 UNPACKING THE STOVE

Read all the instructions before continuing to unpack or install this stove. Carefully lift the stove from the carton. Check that the contents correlate with the component checklist below. Please dispose of all packaging at your local recycling centre.

// 6.0 SITE REQUIREMENTS

It should be noted that the appliance creates warm convected air currents. These currents move heat from the room surroundings to, and up the wall surfaces adjacent to the heater.

Installing the heater next to these types of wall coverings or operating the heater where impurities in the air, (such as tobacco smoke) exist, may slightly discolor wall finishing.

If the appliance is to be secure on a dry lined or timber framed construction then the integrity and ability of the wall to secure the appliance must be confirmed. It is important in these circumstances that any vapor barrier and/or structural members of the house frame are not damaged.

If you are unsure of the ability of the wall to secure the appliance and/or which type of wall fixing to use, you should take professional advice and obtain the correct fixings. Alternatively, find a more suitable wall location.

DO NOT recess any part of the appliance into the wall, or run the supply cable under carpets.

DO NOT site in a position where curtains or drapes could cover the appliance, or other soft materials could cover e.g. below a coat rack. DO NOT site behind an opening door where

mechanical impact/damage could occur. DO NOT site where the supply cable would

become a trip hazard.

DO NOT sit, stand or forcefully pull on the appliance.

 $\ensuremath{\text{DO}}$ NOT obstruct, cover or force items into the openings.

DO NOT use the heater to dry clothes. DO NOT site/use in an outdoor location(s).

It is important that the following clearances are maintained from the appliance to combustible materials. These clearances are dependent on the securing location as defined on the following pages.

7.0 CLEARANCES TO COMBUSTIBLES

The minimum distance to the front of the appliance is 900mm.

There are no clearances for above the appliance, apart from being clear of curtains and drapes.

// 8.0 INSTALLATION – OPTIONAL STOVE PIPE



 With a cross headed screw driver unscrew the two (2) countersunk head screws from the decorative grill plate on top of the appliance. Carefully leaver the decorative grill plate off of the top of the appliance through the screw holes.





2. Using two (2) people, move the appliance to where you would like it to be installed. Insert the small end of the Flue Pipe into the top recessed hole on the appliance, also ensuring that the opposite flanged end of the pipe is touching the wall.





 Place the Flue Pipe back into its final position and secure the Flue Pipe to the wall by fastenings provided into the wall anchors.



3. With a pencil, mark through the two (2) holes at the top of the Flue Pipe on the wall. Remove the Flue Pipe and drill two holes using a 8mm drill bit, 40m deep. (For hard wall installations only). For plasterboard walls use an alternative fixing method shown in section 8.0. Insert the wall anchors into the holes in the wall using a hammer.

// 9.0 OPERATING THE APPLIANCE

The unit can be operated either by the control panel located on the front of the unit (behind the stove door) or using the remote control supplied. For the unit to operate, the manual ON/OFF switch, located on the left hand side of the control panel must be switched to the "l" position.

NOTE: Before attempting any operation with the remote control, press and slide the battery door (on the back of remote) open and insert two AAA batteries, checking that the \bigoplus and \bigcirc sides of the battery match inside the battery compartment, close the battery door.

The unit may emit a slight, harmless odour and smoke when first used. This odour & smoke is normal and it is caused by the internal heating of the internal heater parts and will not occur again.

The functions below can be controlled either by control panel on the appliance or by the remote control, before the POWER on the appliance is turned on, ensure the manual ON/OFF switch is switched to the "I" position



// POWERING THE APPLIANCE

Press the Power button to supply power to all functions of the fireplace and put the fireplace in a standby mode and the current room temperature will be shown on the display.

Press the Power button again to turn off all functions.

NOTE: All previous setting are held in memory, so the next time you power up the fireplace, the unit will turn on with the same settings.

// TEMPERATURE SETTING

Adjust the temperature to the desired setting (15° to 30°C Range) using the $(\Rightarrow) \& (\Rightarrow)$ buttons.

NOTE: The set temperature must be above the room temperature for the heating function to operate.

// HEATER OPERATION

Press the Heater button to select Full Heat setting (2000W) and H2 with the red flame symbol will be displayed.



Press the Heater button again to select Half Heat setting (1000W) and H1 with the orange flame symbol will be displayed.





// OPEN WINDOW DEVICE FUNCTION:

This appliance has open window detection function, when the heater is on operation (H1 or H2), once the ambient temperature drops 5° C within 10 minutes, the digital display will continue to show 'ECO'. This means there is window open or there may be a cooling item opened, at the same time the heater is off. Close the window or cooling items, press the heater button on the appliance or remote control to restart the heater.

NOTE: On either heater setting, the heat function will turn off when the room temperature reaches the set temperature. The heat function will automatically restart when the room temperature drops 3°C below the set temperature. Press the Heater button again to turn off the Heater function.

NOTE: The fan will run for approximately 30 seconds after the Heater function is turned off to remove any residual heat from the unit, to protect the control components from any potential overheating.

// 9.0 OPERATING THE STOVE

// FLAME OPERATION

By pressing the Flame Picture button, you can select from four different Flame Picture options:

NOTE: When one of these modes has been selected, this mode will be the default mode when the unit is turned on by manual or remote operation.

// BRIGHTNESS OPERATION

The brightness setting of the Flame Picture can also be adjusted by pressing the Brightness button to select from the following levels:

// BY REMOTE CONTROL ONLY

Setting the Time & Day (24 hour clock)

- 1. Press the Power button to turn the unit on.
- 2. Press & hold the Time Setting button for two seconds to display the time & day (no numbers shown as time not set)
- 3. Press the Time Setting button & the day setting will flash.
- **4.** Adjust the day setting using $(\rightarrow \& \bigcirc)$ buttons.
- 5. Press the Time Setting button & the hour setting will flash. Adjust the hour setting using the (+) & (-) buttons.
- 6. Press the Time Setting button & the minute setting will flash. Adjust the minute setting using the (+) & (-) buttons.
- 7. Press the Time Setting button to set the time & exit the time/date set-up.

NOTE: The brightness setting can be only set by using the remote control.

// SETTING THE WEEKLY TIMER

The Timer allows for two ON/OFF periods (M1/M2) for each day of the week and the timer can be set using the following procedure:

- 1. Press the Power button to turn the unit on.
- 2. Press & hold the Timer Mode 'M' button for two seconds to enter the timer settings. The settings for the 1st ON/OFF period (M1) for Monday will be shown with the 1st ON time & hour setting flashing.
- **3.** Adjust the hour setting using the $(\rightarrow \& \bigcirc$ buttons and press the Time Setting button to select the minute setting. With the minute setting flashing, adjust the minute setting using the \oplus & \bigcirc buttons.
- 4. Press the Time Setting button & the display will move to the 1st OFF time setting.
- 5. Repeat steps 2 & 3 to set the 1st OFF time.
- 6. Press the Time Setting button & the display will move to the 2nd ON/OFF period (M2) with the 2nd ON time setting displayed.
- **7.** Repeat steps 2 to 5 to set the 2nd ON/OFF period.
- 8. Press the Time Setting button & the display will move to the 1st ON/OFF period (M1) for Tuesday with the 1st ON time setting displayed.
- 9. Repeat steps 2 through 8 for Tuesday's until Sunday's settings.
- **10.** Having confirmed Sunday's settings, exit the timer settings by not using the remote for 10 seconds and the unit will default into normal operating mode. To activate the timer settings, press the Timer Mode buton until the timer symbol is displayed on the screen.

NOTE: The time & day must be set before the Timer Mode can be activated. The unit can still be operated normally when in the timer mode using the Heater function.setting flashing, adjust the minute setting using the (+) & (-)buttons.



// 10.0 SAFETY CUTOUT SYSTEM

This product has one non-self-resetting overheat protection device (thermal cut-out) which will activate if the air inlets or outlets are obstructed. For safety reasons the fire will NOT switch on again automatically, the following procedure must be carried out before the fire can be operated.

NOTE: The visual effect will remain operational if the cutout is activated, only the fan heater is prevented from working.

Switch OFF the appliance at the wall socket or outlet. Leave the fire OFF for a period of no less than 10 minutes, ensuring all obstructions are removed. Switch the appliance ON at the wall. Ensure the appliance is turned ON at the control switches. If the fire fails to operate correctly, repeat the above procedure. If an attempt to switch on the appliance is made before the safety cutout has reset, the appliance may cutout for a further period of time. If the sequence has been followed correctly and the appliance still fails to function, check the fuse in the wall outlet. If this is not the cause, call an electrician or maintenance engineer.

// 11.0 CLEANING AND MAINTENANCE

ALWAYS disconnect the stove from the mains supply before undertaking any maintenance of the appliance.

For general cleaning use a soft clean duster - never use harsh abrasives or cleaners. The glass viewing screen should be cleane dcarefully with a soft cloth.

If in doubt consult a gualified electrician. Refer to Section 3.0 Appliance Data for fuse specification. Excluding fuses, use only genuine manufacturers spare parts available from your supplier.

// REPLACING THE REMOTE CONTROL BATTERY:

When the battery becomes weak, the range of the remote control becomes shorter. Replace with two (2) new AAA batteries.

- 1. Slide open the battery cover on the back of the remote control.
- 2. Insert two new AAA batteries into the remote control.
- 3. Place the battery cover back onto the remote.

NOTE: Keep the batteries out of the reach of children.







// 12.0 TROUBLESHOOTING GUIDE

If the temperature in the room is higher than the temperature selected on the fire, then the thermostat will stop the heater from turning on. For example, if the room temperature is 22°C or above and the fires heater is set at 22°C, then the heater will not be required until the room temperature drops below 22°C. If this is the case select a higher temperature setting than the room's temperature and the heater will begin to operate. The safety cut-out may have been operated. Switch the appliance off, leave for two minutes then switch back on. |

// 14.0 SERVICING

marked with an N or coloured black. The brown wire must be connected to the terminal marked with an L or coloured red. The green/yellow wire must be connected to the earth terminal which is marked with an E or with the earth symbol.

NOTE: If a moulded plug is fitted and has to be removed take great care in disposing of the plug and severed cable, it must be destroyed to prevent engaging into a socket.
